

# Digital Object Identifiers (DOIs) for ESDIS

## Introduction

- The Earth Science Data and Information System (ESDIS) Project is in the process of gathering and registering Digital Object Identifiers (DOIs) for products supported by ESDIS. Currently only data products supported by NASA are being registered.
- ESDIS uses Datacite (<https://citation.crosscite.org/>) to register DOIs for ESDIS Earth science data products. The DOIs assigned are listed by [Data Provider](#) here on the Earthdata Collaboration Environment
- This space on the Earthdata Wiki is meant to describe the ESDIS DOI process and provide guidance for registering and reserving DOIs.

Specifically restricted conduct includes trolling, flaming, ranting, personal attacks, harassment, threats, doxing, racism, discrimination, hate speech, sexism, spamming, off-topic posting, pyramid quoting, rumor mongering, impersonation, advertising (including HTML links and pictures), and linking to applications or utilities of uncertain intent.
